RAG	A public art gallery with Regional Gallery status. RAG has two locations. In Cleveland five exhibition spaces and two Foyer Art Features are contained within the Council Administration Building. A second gallery space is situated adjacent to the Library at Capalaba Place. RAG does not operate as a commercial gallery or dealer but allows the sale of artworks, especially by exhibiting artists, under specified conditions.
